SUBJECT: Authorization to Staff the 2015 Summer Cadet Training Schools

1. The purpose of this memorandum is to identify those senior members who have been selected to staff Pennsylvania Wing's 2015 Summer Cadet Training Schools.

2. This authorization is conditional on maintaining CAP membership standards. Selected members identified below who fail to maintain a good standing within CAP standards will not be permitted to staff our summer schools. It is important that selected seniors strive to achieve the following:
 - a. Every senior member must ensure they continue to actively participate with their local unit and maintain good standing within their local unit. Senior members will be required to register online for the summer schools through the official Cadet Training Schools website (<https://cts.pawg.cap.gov/>). Registration will open in April 2015 and unit commanders will again provide their approval recommendation to attend our activity.

 - b. Every senior member must ensure they maintain their Safety Education Training in accordance with CAP Regulation 62-1, Section 4. Our expectation is that senior members will not allow their safety education currency to become delinquent between now and the end of June 2015. Senior members who do not maintain their safety currency through June are considered non-active CAP members and will not be eligible to staff our schools.
